(e) Project Outline: The Austen Quarry Stage 2 Extension involves the extension of the approved extraction area and overburden emplacement by approximately 25.7ha. Annual production would remain at the approved level of 1.1 million tonnes per annum and extend the life of the quarry by an additional 30 years. Excluding the additional extraction and overburden emplacement area activities, operations would continue as currently approved and involve on-site crushing and screening of rhyolite, transport of products via road registered trucks, progressive rehabilitation of the extraction area and related ancillary activities.
